Westbury Civic Club Policy: Prohibited Yard Parking

Purpose:

The intent of this document is to notify residents that a Prohibited Yard Parking Requirement Area has been established in Westbury Sections 1 through 5, Parkwest Sections 1 through 3, and in Westbury South.

Description:

An application by the Westbury Civic Club to establish a Prohibited Yard Parking Requirement Area under Section 28-303 of the Code of Ordinances of the City of Houston was approved by Houston City Council in November of 2009. Here is a description of the ordinance as it was established in Westbury in 2009.

"It shall be an offense for any person to park or to cause, suffer or permit the parking of a vehicle or equipment on any surface that is not an improved surface as defined in this article, within any front or side yard of a single-family residence in a residential area subject to this section."

The penalty for violating this city ordinance is: "Any person who violates any provision of this article shall be guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine not to exceed \$150.00. Each day a violation of this article shall continue shall constitute a separate offense."

Policy approved and adopted by the Board on this 20th day of November, 2013.
